Pre-registration is recommended. There will be a limit of 50 dogs. Once the limit is reached no more dogs will be accepted. Limited day of event registrations will be accepted. There is a \$10 non-refundable fee to take the test. If time permits we will allow a retesting of dogs who have failed only 1 item. Retesting will occur at the end of the event if time permits. There is no guarantee that retesting will happen. The test is open to the public and to all breeds of dogs.

General Agreement

I (we) agree that the **The Dog Squad** has the right to refuse this entry for cause, which The Dog Squad alone shall deem to be sufficient. In consideration of the acceptance of this entry, of the holding of the event and of the opportunity to have the dog participate and/or to be judged, I (we) agree to hold The Dog Squad, AKC and the City of San Leandro, including their members, officers, directors, agents and employees, sponsors of the event, and owners of the premises upon which the event is held and their employees harmless from any claim for loss or injury that may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim. I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, appearance, theft, damage or injury, be cause or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.
